This has reference to the following :

1. Your application for requesting for the B.Ed. Degree course for the academic year 2006-07.
2. NCTE Letter No. WRC/12-32/123256/75/2005/5890 Dated. 22 July 2005 received from the Regional Director, Western Region, NCTE, Bhopal giving recognition of Secondary level Teacher Institution, with an intake of 100 students for B.Ed. course for the academic year 2005-2006
3. Hon'ble Supreme Court Judgement dated. 31/03/2006 in the Appeal (Civil) 1859 of 2006, in respect of State of Maharashtra V/s Sant Dayaneshwar Shikshan Shashtra Mahavidyalaya & Others
4. Recommendation of Academic Council on the basis of LIC report, the University is pleased to grant the First Time Affiliation to "Shri. Tuljabhavani Bahuddeshiya Samajsevi Sanstha's " College of Education at Madha Tal. Madha Dist. Solapur for the B.Ed. College with intake capacity of 100 students to be conducted at Madha, Tal : Madha Dist : Solapur.

The First time of Affiliation is granted, subject to the submission of written undertaking by the Trust, agreeing to fulfill all the condition of affiliation as stipulated under section 81,82 and 83 of the Maharashtra University Act, 1994, within prescribed time limit, and that in default, the first time affiliation so granted shall be withdrawn/terminated, as per the procedure laid down for the purpose.

It may be noted that the First Affiliation has been granted for one academic year (i.e. 2006- 2007) to teach the following subjects methods at the B.Ed. degree course

B.Ed.(Marathi Medium)

1. Marathi Method
2. English Method
3. Hindi Method
4. Mathematics Method
5. Science Method
6. History Method
7. Geography Method

The First time affiliation to the B.Ed.degree course for the academic year 2006-07 is granted on the following terms and conditions:

1. That the Trust / Samstha / Mandal / Society shall appoint the Following staff as per the qualifications and procedures prescribed by the University Grants Commission / University:
 - i. Teaching staff including Principal.
 - ii. Librarian.
 - iii. Non Teaching staff and
 - iv. Technical / Laboratory Staff, wherever applicable
2. That the Trust / Samstha / Mandal / Society shall meet the financial Deficits, if any, by making an outright grant to the College from its own funds.
3. That the Trust shall maintain the rosters for reservation of posts of Teaching and non-teaching staff, as per the reservation policy of the State Government and maintain service books and the provident fund registers of all employees.
4. That the Trust shall provide facilities for library, books and journals, Furniture, fixtures and fittings for class room, office, laboratories, Library and staff room.
5. That the Trust shall constitute the Local Managing Committee, as Prescribed under Section 85 of the Maharashtra Universities Act, 1994.
6. That the Trust shall comply with the conditions laid down by the Concerned State Government with regard to admission of students belonging to SC/ST/DT/NT/OBC categories.
7. That the Trust shall comply with the Orders / directives issued by the Chancellor, the Vice Chancellor and other officers of the University in Exercise of the powers conferred on them under the provisions of the Act, Statutes, Ordinances, Rules and Regulations.
8. That the Trust shall send to the University, the progress reports of the



Compliance of the above conditions from time to time.

9. That the Trust/ Samstha / Mandal / Society shall give an undertaking on stamp paper worth Rs.100/- wherein it will agree to comply with all the conditions for affiliation laid down under Section 81 of the Maharashtra Universities Act, 1994 and also agree to abide by the rules and regulations as may be framed by the University from time to time.

10. The conditions of First Time Affiliation and the observations stipulated by the Local Inquiry Committee, shall also be complied with by the Trust/ Samstha / Mandal / Society immediately.
